The Supplier must protect its employees from harassment, bullying and victimization in the workplace, including all forms of sexual, physical and psychological abuse, or threat of any such treatment.

The Supplier is expected to comply with applicable laws and regulations as well as international conventions and declarations concerning discrimination in hiring and employment practices.

Labour

The Supplier is expected to comply with all applicable local health and safety laws and regulations in the countries in which they operate as well as the applicable international conventions and declarations such as the ILO Declaration on Fundamental Principles and Rights at Work.

Environment

Yatshun respects the environment and is committed to operate in compliance with applicable laws and regulations. Our Suppliers are also expected to conduct their operation in a way that protects the environment and comply with all applicable environmental laws and regulations in the country in which they operate. The supplier shall strive to reduce the impacts of its activities and products on the environment and work towards and take necessary measures in order to prevent pollution, to conserve and use rationally the natural resources required for its operations and implement relevant emergency response plans and procedures.
